    - i. Step 1: Advise landowner to use Town of Colfax website as a resource. Give them a pamphlet if available.
    - ii. Step 2: Have the landowner talk to Dunn County Zoning to see if the land division plan is feasible.
    - iii. Step 3: Obtain correct application from D.C. Zoning.
      - Minor Subdivision Application for division of property into 4 or less parcels.
      - 2. Major Subdivision Application for more than 4 parcels.
      - 3. Have a CSM created for parcel to be divided.
    - iv. Step 4: Minor Subdivision applications, diagrams and CSMs need to be submitted to the Town of Colfax by the 2<sup>nd</sup> Wednesday of the month to be considered at the Plan Commission Meeting held on the 4<sup>th</sup> Wednesday of the month. Major Subdivisions Applications need to be submitted by the 1<sup>st</sup> Wednesday of the month to be considered for approval by the Plan Commission.
    - v. Step 5: We strongly recommend the applicant or their representative be present at the Plan Commission meeting.
- 6. Dates for possible combined meeting with the Town Board: May 8<sup>th</sup> will work for Plan Commission to meet with the Town Board. Unless they would like another date.
